SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF

GREENVILLE, in the full and just sum of Seven Thousand One Hundred & no/100 (\$7,100.00 Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of...

Fifty Three and 83/100 - - - - - -) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. M C. Office for Greenville County in Plat Book LL at Page 59, said plat being prepared by J. C. Hill, L. S., June 1, 1956, and said lot having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Oakvale Drive, joint front corner Lots Nos. 16 and 17, and running thence with the joint line of said lots, S. 71-30 E. 122.8 feet to an iron pin in the rear line of Lot No. 15; the joint rear corner of Lots Nos. 16 and 17; thence with the rear line of Lot No. 17, S. 11-50 W. 75.5 feet to an iron pin, in the rear line of Lot No. 18, the joint rear corner of Lots Nos. 17 and 20; thence with the joint line of said lots, N. 71-30 W. 131.6 feet to an iron pin on the eastern side of Oakvale Drive, the joint front corner of Lots Nos. 17 and 20; thence with the eastern side of said Drive, N. 18-30 E. 75 feet to the point of beginning; being a portion of the property conveyed to the mortgagor corporation by L.
