

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Leonard D. Smith, of Greenville County

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF no/100

GREENVILLE, in the full and just sum of Four Thousand Five Hundred Fifty & (\$4,550.00 Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Forty Five and 50/100 - - - - - - (\$45.50) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest computed worthly on the sum of the payment of interest computed worthly on the sum of monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 11-7/kears after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

O. Berry as shown on plat thereof made by H. S. Brockman, R. S., on May 10 and 11, 1950 and recorded in the R. M. C. Office for Greenville County in Plat Book X at Page 193, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northwest corner of the intersection of Lily Street and Berry Avenue, and running thence along the west side of Berry Avenue, N. 15-55 W. 122.6 feet to an iron pin; thence S. 62-10 W. 100.5 feet to an iron pin at the rear corner of Lot No. 7; thence along the line of Lot No. 7, approximately S. 27-50 E. 120 feet, more or less, to an iron pin at the corner of said lot on the north side of Lily Street; thence along the north side of Lily Street, N. 62-10 E. 75 feet to the beginning corner; being the same conveyed to me by J. E. Howard by deed dated January 26, 1953 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 471 at Page 349.
