# MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, WILLIAM J. BURKS of  
Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

AIKEN LOAN & SECURITY COMPANY

, a corporation  
organized and existing under the laws of South Carolina, hereinafter  
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which  
are incorporated herein by reference, in the principal sum of Twelve Thousand Three Hundred Fifty  
Dollars (\$ 12,350.00 ), with interest from date at the rate of five & one-fourth per centum  
( 5 1/4 %) per annum until paid, said principal and interest being payable at the office of  
Aiken Loan & Security Company in Florence, South Carolina,  
or at such other place as the holder of the note may designate in writing, in monthly installments of  
Seventy-four and 10/100 -----Dollars (\$ 74.10 ),  
commencing on the first day of December, 1958, and on the first day of each month there-

if not sooner paid, shall be due and payable on the first day of November, 19 83.

securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville,  
State of South Carolina:

All that lot of land in the County of Greenville, State of South  
Carolina, known and designated as Lot No. 140 on plat of BELLE MEADE  
subdivision, recorded in Plat Book EE, pages 116-117 of the R.M.C.  
Office for Greenville County, S. C., said lot having a frontage of  
70 feet on the southeastern side of Pine Creek Drive, a parallel  
depth of 175 feet and a rear width of 70 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-  
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be  
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter  
attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and  
assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple
