Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

GENERAL MORTGAGE CO.

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Fourteen Thousand Five Hundred Dollars (\$ 14,500.00 ), with interest from date at the rate of Five & one-fourth per centum ( 5 1/4 % ) per annum until paid, said principal and interest being payable at the office of General Mortgage Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Eighty-seven and No/100----- Dollars (\$ 87.00 ), commencing on the first day of January, 19 59, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of December, 19 83.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon situate at the Northwest corner of the intersection of York Circle and East Dorchester Boulevard, near the City of Greenville, in Greenville County, State of South Carolina, being shown as the greater portion of Lot 104 on Plat of Belle Meade Subdivision, made by Piedmont Engineering Service, June, 1954, recorded in the RMC Office for Greenville County, S. C., in Plat Book "EE", pages 116 and 117, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the North side of East Dorchester Boulevard at joint front corner of Lots 104 and 105, and running thence with the line of Lot 105, N. 46-54 W., 177.5 feet to an iron pin; thence N. 64-41 E., 123.5 feet to an iron pin on the West side of York Circle; thence along York Circle (the chord being S. 33-25 E., 85 feet) to an iron pin; thence continuing with the curve of York Circle (the chord being S. 46-54 E., 25 feet) to an iron pin; thence with the curve of York Circle and East Dorchester Boulevard (the chord being S. 1-54 E., 35.4 feet) to an iron pin on the North side of East Dorchester Boulevard; thence with the North side of East Dorchester Boulevard, S. 43-06 W., 70 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
