We, Fred H. Roberts and Eunice J. Roberts of Greenville County, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto General Mortgage Co.

organized and existing under the laws of South Carolina, a corporation hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eleven Thousand Seven Hundred Dollars (\$11,700.00), with interest from date at the rate of five and one-fourth per centum (5-1/4%) per annum until paid, said principal and interest being payable at the office of General Mortgage Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Seventy and 20/100..... Dollars (\$70.20), commencing on the first day of January, 1959, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of December, 1963.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville being known and designated as Lot No. 2 of the property of W. T. Patrick and William R. Timmons, Jr. as shown on a plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book PPat Page 131 and having, according to a more recent survey prepared for Fred H. Roberts and Eunice J. Roberts by R. B. Bruce, R. L. S. dated September 16, 1958 the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwestern side of Nicholas Drive, joint corner Lots Nos. 1 and 2 and running thence with Nicholas Drive, S. 34-20 E. 125 feet to an iron pin; thence continuing with Nicholas Drive as it intersects with Salem Court, following the curvature thereof, the chord of which being S. 10-40 W. 35.3 feet to an iron pin on the Northwestern side of Salem Court; thence S. 55-40 W. 105 feet to an iron pin, joint corner Lots Nos. 2 and 3; thence with the joint line of said lots, N. 34-20 W. 150 feet to an iron pin, the joint corner of Lots Nos 1, 2 and 3; thence with the joint line of Lots Nos. 1 and 2, N. 55-40 E. 130 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
