"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about two miles west of Greer, lying on the western side of Brannon Road, having the following courses and distances, to-wit:

BEGINNING on an old iron pin on the western margin of the said road, Robert L. Hammond corner, and runs thence with the Hammond line, S. 57-45 W. 210.9 feet to an iron pin (old) on the said line and joint corner of the Ansel Hughes lot; thence with the Hughes line, N. 76-15 W. 110.6 feet to an iron pin on the said line, new corner; thence a new line, N. 57-45 E. 285.7 feet to an iron pin on the western margin of the said Brannon Road; thence with the western margin of the said road, S. 30-25 E. 80 feet to the beginning corner.
