C. Boroughs on the 1st day of February, 1955, and recorded in the R. M. C. BEGINNING at an iron pin on the northern side of Arden Street, at the corner of Lot No. 72 which pin is 258.3 feet from the intersection of Arden Street and Maco Street and running thence with the line of Lot No. 72, N. 25-30 W. 100 feet to a stake in the line of Lot No. 75; thence with the line of Lot No. 75, N. 64-30 E. 70 feet to a stake; thence S. 25-30 E. 100 feet to a stake on the northern side of Arden Street; thence with the northern side of said Street, S. 64-30 W. 70 feet to the point of beginning."

The said mortgage retains however the said mortgage in full force and effect over the remaining portion of the property described in said mortgage.
