GREENVILLE, in the full and just sum of Seven Thousand Nine Hundred & no/100,87,900.00 Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of...

Fifty Nine and 90/100 - - - - - - - - - - - - - - - (\$59.90 each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. "All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the east side of Pinefield Drive, near the City of Greenville, being shown as Lot No. 123 on plat of South Forest Estates made by Pickell and Pickell, Engineers, August 29, 1955, recorded in the R.
