WHEREAS, the Mortgagor is well and truly indebted unto

THE WESTERN AND SOUTHERN LIFE INSURANCE COMPANY

ALL that lot of land with the buildings and improvements thereon, situate on the North side of Pacific Avenue, in the City of Greenville, in Greenville County, S. C., being shown as the Western one-half of Lot 343 and the Eastern one-half of Lot 344 on plat of Pleasant Valley, made by Dalton & Neves, Engineers, April, 1946, revised through July, 1954, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "BB", page 163, said lot fronting 60 feet along the South side of Pacific Avenue, running back to a depth of 160 feet on the East side, to a depth of 160 feet on the West side, and being 60 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
