WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of ~~Eighty-Five Hundred and No/100~~-----

DOLLARS (\$ 8500.00 ), with interest thereon from date at the rate of Five & One-Half per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the Northwestern side of Mohawk Drive (formerly Old Chick Springs Road) in the City of Greenville, being known and designated as lot # 24, on plat of Northwood, recorded in Plat Book J at Pages 102 and 103, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Mohawk Drive (formerly Old Chick Springs Road) at the joint front corner of lots 23 and 24, and running thence along line of lot # 23, N. 30-06 W. 179 feet to iron pin in line of lot # 51; thence with line of lot # 51, N. 9-16 E. 12 feet to an iron pin at corner of lot # 49; thence with line of lot # 49, N. 70-50 E. 60 feet to iron pin at rear corner of lot # 25; thence with line of lot # 25, S. 28-#. 175.6 feet to an iron pin on Mohawk Drive; thence along Northwestern side of said Drive, S. 58-20 W. 60 feet to the beginning corner.
