TO ALL WHOM THESE PRESENTS MAY CONCERN:

KATHRYN SIMS (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-one Hundred and No/100 -----

DOLLARS (\$ 4100.00 ), with interest thereon from date at the rate of five & three-fourths per centum per annum, said principal and interest to be repaid as therein stated, and (5 3/4%)

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwest side of Lake View Drive (formerly Putman Road), near the City of Greenville, being shown as Lots 17, 18 and 19 on revised plat of Farr Estate, made by W. J. Riddle, October, 1941, recorded in Plat Book L at Page 131, and described as follows:

BEGINNING at a stake on the northern side of Lake View Drive 637.3 feet northeast from Cedar Lane Road at corner of Lot 20, and running thence with lines of Lots 20 and 4, N. 31-00 W. 490 feet to stake at corner of Lot 23; thence with the line of said lot N. 65-30 E. 626.7 feet to a stake; thence S. 50-15 E. 484 feet to a stake on western side of Lake View Drive; thence with the western side of Lake View Drive to the beginning corner, the chords of which are as follows: S. 8-10 W. 100 feet, S. 35-45 W. 150 feet, S. 61-00 W. 100 feet, S. 70-30 W. 188 feet and S. 84-30 W. 334.5 feet to the beginning corner.

LESS, HOWEVER, two parcels of land heretofore conveyed by the mortgagor by deeds recorded in Deed Book 517, Page 168, and Deed Book 602, Page 487. The land covered by this mortgage is shown on the county block book as Lots 10, 11 and 12 of Sec. 3 on Page B.10 of the County Block Book.

The above premises are the same conveyed to the mortgagor by deed recorded in Deed Book 332, Page 411.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
