BEGINNING at an iron pin on the west side of U. S. Highway No. 25, at the southern corner of Lot No. 23, and running thence with the right-of-way of Highway No. 25, S. 4-09 E., 133.1 feet to the north side of Ellendale Avenue; thence with the north side of Ellendale Avenue, S. 32-21 W., 66.7 feet to the center of line of Old Paris Mountain Road; thence with the center of Old Paris Mountain Road, N. 3-50 E., 138.6 feet to an iron pin in line of Lot No. 23; thence with the line of said property, N. 85-51 E., 47.2 feet to the point of beginning.
