All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, containing 3.75 acres, more or less, according to a survey of W. P. Morrow, and having, according to a plat thereof, the following metes and bounds, to-wit:

Beginning at an iron pin on the Geer Highway and running S 64-30 W, 888 feet to an iron pin on the North Saluda River; thence along the meanderings of said river N 22 W, 195 feet; thence N 65-00 E, 828 feet to an iron pin on the Geer Highway; thence S 39-30 E, 195 feet to the beginning corner.
