Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto C. Douglas Wilson & Co.

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **TWELVE THOUSAND ONE HUNDRED** Dollars (\$12,100.00), with interest from date at the rate of **five & one-fourth** per centum (5 1/4 %) per annum until paid, said principal and interest being payable at the office of C. ALL That piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, known and designated as Lot No. 197, Camden Lane, as shown on plat of the subdivision of Belle Meade (Sections 1 & 2), recorded in the R.M.C. Office for Greenville County in Plat Book EE, Pages 116-117.
Size of lot: 75' x 141.4' x 103.7' x 20.5' x 171.5'.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
