WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Sixty Thousand

DOLLARS (\$ 60,000.00 ), with interest thereon from date at the rate of five & one-fourth per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or ~~lot~~ tract of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the city of Greenville, on the east side of Keith Drive, being a portion of the property shown on plat made for E. M. Sweat by J. Mac Richardson, recorded in the RMC Office for Greenville County in plat book X page 116, and being more particularly described according to plat made by Dalton & Neves, as follows:

Beginning at an iron pin on the east side of Keith Drive, at corner of property formerly of Estate of R. F. Watson; thence with the east side of Keith Drive S. 9-06 W. 57.3 feet to an iron pin; thence continuing S. 12-36 W. 355.7 feet to an iron pin; thence with a new line N. 84-58 E. 564.2 feet to an iron pin; thence N. 30-44 W. 551 feet to an iron pin corner of Watson property; thence with line of said property S. 58-35 W. 230.5 feet to the beginning corner.

This is the same property conveyed to mortgagor by James W. Curdts, Trustee by deeds recorded in book 601 page 292 and book 606 page 501, of the RMC Office for Greenville County.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
