C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) the said mortgagor \_\_ in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, being bounded on the north by other lands of J. T. Collins, on the east by the road that leads off of the Groce Meadow road to Sandy Flat and other lands of J. T. Collins, on the south by lands of Blackwell and on the west by lands of Mrs. Barbare, and being a part of a 46.00 acre tract on which J. T. Collins home is located, and having the following courses and distances, to wit:-BEGINNING on an old stone
