released, and by these presents do grant, bargain, sell and release unto the said  
E. F. Galloway, his heirs and assigns,

All those certain lots of land in Greenville Township, Greenville County, State of  
South Carolina, just outside the corporate limits of the City of Greenville, known  
as Lots Nos. 42, 43, 44 and 45, in Block A, on plat of survey of lands of W. M.  
Norwood known as Norwood Heights, made by W. D. Neves, and recorded in Plat  
Book E, pages 215 and 216 in Office of RMC for Greenville County, and having,  
according to said plat, the following metes and bounds, to-wit:
