MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

John J. Davis

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Margaret Hendrix

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

One Thousand Eight Hundred
and No/100 -0----- DOLLARS (\$ 1,800.00),

with interest thereon from date at the rate of six per centum per annum, said principal and interest to be repaid:

\$18.67 on July 10th, 1959, and \$18.67 on the 10th day of each successive month thereafter, until paid in full; with interest thereon from date at the rate of six per cent, per annum, to be computed and paid monthly, until paid in full;

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Butler Township, on the Southern side of the Woodruff Road, containing 2.69 acres, and having, according to a Plat of the property of John J. Davis made by J. C. Hill, June 8, 1959, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Woodruff Road, which pin is 50 feet in an Easterly direction from the original corner, and running thence with the line of property of Hendrix, S. 17-30 W. 401.5 feet to an iron pin; thence S. 74-55 E. 299.5 feet to an iron pin; thence N. 19-30 E. 145 feet to an iron pin; thence continuing N. 5 E. 257.8 feet to an iron pin on Woodruff Road; thence with the Southern side of Woodruff Road, N. 73-50 W. 249.6 feet to an iron pin, the point of beginning.

The above described property being the same conveyed to the Mortgagor by the Mortgagee by Deed of even date to be recorded herewith.

It is understood and agreed that this Mortgage is second and junior in lien to Mortgage this date executed by the Mortgagor to Fidelity Federal Savings & Loan Association in the amount of \$6,500.00 to be recorded.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
