

, to be paid in four (4) payments, One-fourth plus interest due each 12 months.

, with interest thereon from date

at the rate of 6 per centum per annum, to be computed and paid in said payments

until paid in full; all interest not paid when due to bear

All of that parcel or tract of land in Chick Springs Township, Greenville County, S.C., about 12 miles southwest of the City of Greer, lying on the West side of a new cut County Road which leads from the Hammett Bridge Road to the Brushy Creek Road, bounded on the North by lands of W. L. James, on the South and East by other lands reserved by the grantor, and on the West by lands of Frank Carmen, having the following courses and distances, according to a plat thereof made by C.C. Henderson, recorded in Book 451,pg.81.
