TO ALL WHOM THESE PRESENTS MAY CONCERN:

LARRY G. SHAW AND JOYCE M.

SHAW

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Nine Thousand Eight Hundred and no/100ths** -----

**DOLLARS (\$ 9,800.00** ), with interest thereon from date at the rate of **six (6)** -----

per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

**November 1, 1979**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the **Northeastern side of Longwood Drive near the City of Greenville, County of Greenville, State of South Carolina**, being known and designated as **Lot No. 42** as shown on a plat prepared by **Jones & Sutherland, Engineers**, dated **December 1, 1958**, entitled **"Final Subdivision Layout, Thornwood Acres"**, recorded in the **R.M.C. Office for Greenville County, South Carolina**, in **Plat Book MM** at **page 59**, and having according to said plat the following metes and bounds:

**BEGINNING** at an iron pin on the **Northeastern side of Longwood Drive** at the joint front corner of **Lots Nos. 42 and 43** and running thence with the line of **Lot No. 43 N. 42-04 E. 169.7 feet** to an iron pin in the rear line of **Lot No. 50**; thence with the rear line of **Lots Nos. 50 and 51 S. 49-08 E. 100 feet** to an iron pin at the joint rear corner of **Lots Nos. 41 and 42**; thence with the line of **Lot No. 41 S. 42-04 W. 170.3 feet** to an iron pin on the **Northeastern side of Longwood Drive**; thence with the **Northeastern side of Longwood Drive N. 47-56 W. 100 feet** to the point of beginning.

This is the identical property conveyed to the mortgagor herein by deed of **W. E. Shaw**, dated **June 24**, 1959, and to be recorded herewith in the **R.M.C. Office for Greenville County, South Carolina**.
