on the Southern side of Buist Avenue in the City of Greenville, being shown as Lot No. 12 on Plat of G. A. Schulze, dated April 10, 1925, subdividing Lots Nos. 7, 8 and 9 of Section E of Buist Land Company recorded in Plat Book C, at page 10, and described as follows:
