bind Ourselves and Our Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said Bobbie J. Blackstone his

Heirs and Assigns, from and against Us and Our Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim the same or any part thereof.

And the said Wayne B. and Betty B. Finley agree to insure the house and buildings on said lot in the sum of not less than Thirty Five Hundred and no/100 Dollars and keep the same insured from loss and damage by fire, and assign the policy of insurance to the said Bobbie J. Blackstone

and that in the event that the mortgagor shall at any time fail to do so, then the said Bobbie J. Blackstone

may cause the same to be insured in his name and reimburse himself for the premium and expense of such insurance under the mortgage.

And it is Agreed, by and between the said parties, that should legal proceedings be instituted for the collection of the debt secured hereby, then, and in that event, the said Mortgagee, His successors or assigns, shall have the right to have a Receiver appointed of the rents and profits of the above described premises, with power to forthwith lease out the said premises anew if he should so elect, who, after deducting all charges and expense attending such proceedings and the execution of the said trust as Receiver, shall apply the residue of said rents and profits toward the payment of the debt secured hereby.

And it is Further Agreed, by and between the said parties, that should legal proceedings be instituted for the foreclosure of this mortgage, or for any purpose involving this mortgage, or should the debt hereby secured be placed in the hands of an Attorney-at-Law for collection, by suit or otherwise, that all costs and expenses incurred by the Mortgagee His or assigns, including a reasonable counsel fee (of not less than ten per cent of the amount involved) shall thereupon become due and payable as a part of the debt secured hereby, and may be recovered and collected hereunder.

Provided Always, Nevertheless, and it is the true intent and meaning of the parties to these presents, that if the said Wayne B. and Betty B.
