with interest thereon from the date hereof at the rate of six per centum per annum, said interest
to be paid on the first day of September 19 59 and thereafter said interest
and principal sum to be paid in installments as follows: Beginning on the firstday
of October 19 59, and on the first day of each month thereafter the
sum of \$ 80.17 to be applied on the interest and principal of said note, said payments to continue
up to and including the first day of August , 19.74, and the balance
of said principal sum to be due and payable on the first day of September , 1974;
the aforesaid monthly payments of \$ 80.17each are to be applied first to interest at the rate
