ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, and known and designated as Lot No. 9 on plat of property of Knox L. Haynsworth, Trustee, prepared by Dalton & Neves, Engineers, May 1941 and recorded in the RMC Office for Greenville County in Plat Book "L", at page 177 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of Cedar Lane Read at the joint front corner of Lots No. 8 and 9 and running thence along the common line of said lots, North 34-0 East 300 feet to an iron pin at the joint rear corner of Lots No. 8, 9, 12 and 13; thence along the rear line of Lot No. 12, North 58-30 West 100 feet to an iron pin at the rear corner of Lots No. 9, 10, 11 and 12; thence along the common line of Lots No. 9 and 10, South 34-0 West 300 feet to an iron pin on the Northern side of Cedar Lane Road; thence along the Northern side of Cedar Lane Road South 58-30 East 100 feet to an iron pin, the beginning corner.
