Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, on the southern side of Brookside Circle, near the City of Greenville, being shown as lot # 121, on a plat of University Park, recorded in Plat Book P at Page 127, and described as follows:

BEGINNING at an iron pin on the southern side of Brookside Circle, 302.3 feet East from Beverly Lane, at corner of lot # 120, and running thence with the southern side of said Circle, N. 60-06 E. 75.7 feet to iron pin at corner of lot # 122; thence with the line of said lot, S. 37-34 E. 148.5 feet to iron pin in line of lot # 93; thence with the line of said lot, S. 52-26 W. 75 feet to iron pin, corner of lot # 120; thence with the line of said lot, N. 37-34 W. 158.2 feet to the beginning corner.
