We, James E. Harrison and Margie Ree ^PHarrison, SEND GREETING:
 Whereas we, the said James E. Harrison and Margie Ree ^PHarrison,
 in and by our certain promissory note in writing, of even date with these
 Presents, are well and truly indebted to John A. Park,

in the full and just sum of TWENTY FIVE HUNDRED and no/100 (\$2500.00) DOLLARS,
 to be paid as follows: THIRTY (\$30.00) DOLLARS on December 11, 1959, and
 a like sum on the ~~to be paid~~ 11th day of each and every succeeding Calen-
 dar month thereafter, each of said payments to be applied first to the
 interest and then to the principal balance owing, for a period of Six
 (6) years, at which time the whole amount of the balance then owing shall
 be and become due and payable, until paid in full; with the right to
 anticipate by payment of all or any part after Two (2) years from date,

, with interest thereon from date,
 semi-annually
 at the rate of 7 per centum per annum, to be computed and paid monthly, as above,

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and
 unpaid, the whole amount evidenced by said note to become immediately due, at the option of the
 holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its
 maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity
 it should be deemed by the holder thereof necessary for the protection of his interests to place and
 the holder should place the said note or this mortgage in the hands of an attorney for any legal
 proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses
 including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness,
 and to be secured under this mortgage as a part of said debt.

All that tract or lot of land in Gantt Township, Greenville County,
 State of South Carolina, being a portion of Tract Number Five (No. 5)
 according to a plat of the estate of Ella Easley, surveyed by R.E. Dalton,
 Engineer, February, 1923, and being more fully described as follows;
 to-wit:

BEGINNING at a stake in the center of the old Augusta Road, at or
 near the line of the Fannie Davidson property and running thence along
 the center of said Road, N. 2-25 W. One Hundred Eighty Five (185) feet
 to a point; thence S. 61-55 W. Seventy Five (75) feet to a point; thence
 S. 2-25 E. One Hundred Eighty Five (185) feet to a point; thence N. 61-55
 E. Seventy Five (75) feet to the point of beginning in center of said
 old Augusta Road.

The above described property is the same conveyed to us by Otis
 Davis by deed dated June 19, 1950, recorded in R.M.C. office.
