TO ALL WHOM THESE PRESENTS MAY CONCERN:

Mrs. Charlie G. Johnson (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Six Thousand Four Hundred and no/100-----

DOLLARS (\$ 6,400.00-----), with interest thereon from date at the rate of Six (6%)----- per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of McCall Street in the City of Greenville, being Lot No. 5 and a lot designated as "J. R. Ware" on plat of the Estate of J. H. Ware, made by R. E. Dalton in November, 1919, recorded in Plat Book E at page 264 and described as follows:

BEGINNING at a stake on the Western side of McCall Street 124.5 feet North from Rhett Street at corner of Lot 6; and running thence with the Western side of McCall Street, N. 18-49 W. 133 feet to a stake at corner of Lot No. 1; thence with the line of said lot, S. 70-52 W. 100.9 feet to a stake in line of Lot 3; thence with the line of Lots 3 and 4 S. 18-49 E. 68 feet to a stake; thence continuing with the line of Lot 4, S. 18-16 E. 51.3 feet to a stake; thence S. 18-45 E. 13 feet to a stake in line of Lot 7; thence with the line of Lots 7 and 6, N. 71-15 E. 101.5 feet to the beginning corner.

Being the same property conveyed to the Mortgagor by deed recorded in Deed Book 395 at page 383.

ALSO: All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being in Greenville Township, in the City of Greenville, State of South Carolina, on the North side of Rhett Street, and having according to a plat thereof prepared by R. E. Dalton, Engineer, on June 10, 1944, which plat is recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book U at page 23, the following metes and bounds, to-wit:

BEGINNING at a stake on the North side of Rhett Street, which point is 66 feet in an easterly direction from the intersection of Rhett Street with McCall Street, and running thence with the North side of Rhett Street, N. 71-52 E. 60 feet to an iron pin; thence N. 17-48 W. 114.6 feet to a concrete post; thence S. 72-03 W. 60 feet to a stake; thence S. 17-48 E. 114.6 feet to the point of beginning, (continued below)

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
