WHEREAS, the Mortgagor is well and truly indebted unto PIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of One Hundred Thousand and No/100 -----), with interest thereon from date at the rate of five & three-fourths DOLLARS (\$ 100,000.00 per centum per annum, said principal and interest to be repaid as therein stated, and (5 3/4%)

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the northern side of Cleveland Street, in the City of Greenville, containing four (4) acres, more or less, and being more particularly described by metes and bounds, as follows:

BEGINNING at an iron pin on the northern side of Cleveland Street at the joint corner of the property of the mortgagor and the YMCA, and running thence with the line of property of the YMCA N. 46-45 E. 417.5 feet, more or less, to pin; thence S. 71-19 E. 421.2 feet to pin in line of property of William Schwiers; thence with the line of Schwiers property S. 46-45 W. 417.5 feet to pin on Cleveland Street; thence with Cleveland Street in a northwesterly direction 419 feet more or less, to the point of beginning.
