WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C.; (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Two Thousand and no/100ths -----

per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Chick Springs Township, Greenville County, State of South Carolina, on the Eastern side of Indian Spring Drive, being known and designated as Lot No. 37 as shown on a plat prepared by Piedmont Engineering Service, dated May, 1957, entitled "Section 2, Lake Forest Heights", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book KK at page 105 and having according to a revised plat prepared by Piedmont Engineering Service, dated April, 1959, entitled "Revision of Lots 37 & 38, Lake Forest Heights, Section 2", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book SS at page 139, the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Indian Spring Drive at the joint front corner of Lots Nos. 36 and 37 and running thence with the line of Lot No. 36 S. 83-23 E. 176.7 feet to an iron pin in the rear line of Lot No. 41; thence with the rear line of Lots Nos. 41 and 40 N. 9-13 E. 72 feet to an iron pin in the rear line of Lot No. 40; thence continuing with the rear line of Lot No. 40 N. 17-07 E. 20 feet to an iron pin at the joint rear corner of Lots Nos. 37 and 38; thence with the line of Lot No. 38 N. 70-54 W. 157.1 feet to an iron pin on the Eastern side of Indian Spring Drive; thence with the Eastern side of Indian Spring Drive, and following the curve thereof, S. 26-00 W. 69.7 feet to an iron pin; thence continuing with the Eastern side of Indian Spring Drive, and following the curve thereof, S. 13-00 W. 60 feet to the point of beginning.
