NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following described real estate situated in the County of

Greenville , State of South Carolina: On the northern side of Botany Road, near the City of Greenville, being shown as Lot No. 57 of Section II of Botany Woods on plat recorded in Plat Book QQ at Page 79, R. M. C. Office for Greenville County, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Botany Road, front corner of Lot No. 56; thence with the line of said lot, N. 30-26 E. 190 feet to an iron pin; thence N. 11-05 E. 140 feet to an iron pin; thence S. 75 W. 178 feet to an iron pin in line of Lot No. 58; thence with the line of said lot, S. 13-45 W. 215 feet to an iron pin on said Road; thence with said Road, S. 69-10 E. 55 feet to a stake; thence with said Botany Road, S. 60-58 E. 55 feet to the beginning.
