(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Five Hundred and No/100-----

DOLLARS (\$ 2500.00), with interest thereon from date at the rate of Six & One-Half per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, on the northern side of Columbia Avenue, being designated as lot # 102 and being a portion of the Riverside property, and described as follows:

BEGINNING at an iron pin on the northern side of Columbia Avenue, joint corner of lots # 101 and 102, and running thence with the line of lot # 101, N. 10-30 E. 150 feet to pin; thence N. 79-35 E. 50 feet to pin; thence S. 10-30 W. 150 feet to iron pin on Columbia Avenue; thence with the northern side of Columbia Avenue, S. 79-35 W. 50 feet to the point of beginning.
