"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the western side of Florida Avenue, near the City of Greenville, being a portion of Lot No. 21 of Block 'C' as shown on plat of property known as Highland, made by the Fitzpatrick Terry Company, in February 1920, recorded in the R. M. C. Office for Greenville County in Plat Book E at Page 209, and described as follows:
