situate on the East side of Rutledge Avenue, near the City of Greenville,
in Greenville County, S. C. being shown as Lot No. 127 on plat of
property of Sans Souci Housing, Inc. made by Piedmont Engineering Service,
January 16, 1950, recorded in the RMC Office for Greenville County, S. C.
in Plat Book X, page 61, said lot fronting 65 feet along the East side
of Rutledge Avenue, running back to a depth of 162.9 feet on the South
side, to a depth of 171.1 feet along the North side, and being 65.5 feet
