To All Whom These Presents May Concern:

VILLE, in the full and just sum of Nine Thousand and No/100 - - - - - - (\$ 9,000.00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

extended, will be due and payable 10 years after date. "BEGINNING at an iron pin on the northern side of Lee Road, the joint front corner of Lots 3 and 4, and running thence along the joint line of said lots, N. 7-46 E. 206.7 feet to an iron pin at the corner of Lot No. 5; thence along the line of that lot, N. 58-30 E. 125 feet to an iron pin at the rear corner of Lot No. 2; thence along the line of that lot, S. 3-19 E. 259.8 feet to an iron pin on the northern side of Lee Road; thence along the northern side of Lee Road, S. 84-07 W. 100 feet to an iron pin; thence continuing along the northern side of Lee Road, S. 89-26 W. 50 feet to the beginning corner; being one of the lots conveyed to me by Clyde L. Parham, et al., by deed dated June 12, 1959 and recorded in the R. M. C. office for Greenville County in Deed Vol. 627, page 162."
