

All those pieces, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina, on the eastern side of Harrison's Bridge Road and the western side of a 50-foot street and being known and designated as Lots Nos. 5 and 19 on plat of property of Walter W. Goldsmith and G. C. Gibson prepared by J. Mac Richardson dated November 1959 and recorded in the R. M. C. Office for Greenville County in Plat Book "QQ", at Page 131 and having, according to said plat, the following metes and bounds, to-wit:
