"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler

Township, lying west from the Pelham Road and about one mile North from Pelham, being a part of Lot No. 3 of the B.C. Vaughn Estate, plat prepared by H.S. Brockman, Surveyor, November 21, 1936, and having the following courses and distances:

BEGINNING on an iron pin on the Burnett line, joint corner of tracts Nos. 1 and 2 on said plat, and runs thence with the Burnett line N. 44-23 W. 76 feet to a black gum; thence N. 1 W. 895.5 feet to a stone, old corner on J.E.McCall line; thence S. 79.08 W. 700 feet to a stake on said line, new corner; thence S. 71-42 W. 295 feet to a stake, new corner, near gap in pasture; thence S. 74-38 W. 427 feet to a stake, new corner; thence S. 25-13 W. 221 feet to a stone (pine stump gone, joint corner of tracts Nos. 2 and 3); thence N. 76.53 E. 129 feet to a poplar 3xom; thence S. 62 E. 216.7 feet to a double white oak; thence S. 55-26 E. 195.5 feet to a sweet gum; thence S. 55-45 E. 685 feet to a stake; thence W. 62-10 E. 537.7 feet to the beginning corner, containing 24.5 acres, more or less, and being all of that land conveyed to the mortgagor by J.E.McCall by deed dated September 12, 1947, recorded in the R.M.C.Office for Greenville County in Deed Book 317, at page 193.
