(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **BANK OF TRAVELERS REST**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Seven Hundred and No/100 --**

with interest thereon from date at the rate of ~~seven (7%)~~ centum per annum, said principal and interest to be repaid: **in monthly installments of \$35.00 each, with interest from date at the rate of seven (7%) per cent, payable annually in advance**

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on waters of Devil's Fork Creek, and according to a partial survey by J. C. Hill:**

BEGINNING at a point in the center of Jerry Heller Branch and the Cantrell line at the corner of W. B. McCarson, and running thence S. 30-30 E. 289 feet to the top of a peek; thence N. 76-15 W. 156.4 feet to an iron pin, black gum down; thence S. 30-30 E. 321.4 feet with White line to an iron pin; thence S. 41-0 W. 685.6 feet to a rock; thence S. 13-0 E. 310.6 feet to an iron pin; thence S. 26-30 W. 695 feet to an iron pin corner of Hubert McCarson property; thence S. 59-10 W. 690 feet to an iron pin corner of McCarson property; thence with his line N. 25-40 W. 329 feet to an iron pin; thence N. 28 W. 400 feet to an iron pin; thence N. 27-15 W. 700 feet to an iron pin; thence N. 25 W. 400 feet to an iron pin; thence N. 68-40 W. 475 feet to an iron pin; thence N. 32-10 W. 337 feet to point, center of Devil's Fork Creek; thence up said creek 372 feet, more or less, to the mouth of Jerry Heller Branch; thence up said branch 2080 feet more or less, to the beginning, and containing 80.92 acres.

Being the same premises conveyed to the mortgagor by deed recorded in Deed Book 605, Page 117.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
