TO ALL WHOM THESE PRESENTS MAY CONCERN:

IMOGENE M. EVINS (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty Thousand and No/100 -----

DOLLARS (\$ 20,000.00 ), with interest thereon from date at the rate of five & one-half (5 1/2) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, containing 15.70 acres, more or less, and having the following metes and bounds, to-wit:

BEGINNING at a point in the intersection of the McElhaney Road and Watson Road, and running thence in the center of the McElhaney Road as the line S. 5-13 W. 133 feet; thence S. 1-15 W. 150 feet; thence S. 0-30 E. 100 feet; thence S. 5-36 E. 100 feet; thence S. 13-48 E. 100 feet; thence S. 19-47 E. 100 feet; thence S. 16-47 E. 100 feet; thence S. 6-27 E. 100 feet; thence S. 1-47 E. 550 feet; thence S. 41-0 E. 100 feet; thence S. 61-30 E. 210 feet to point in line of Houston Batson property; thence with the line of the last mentioned property N. 38 1/2 E. 705 feet; thence N. 34 1/2 W. 19.50 chains to point in the center of the McElhaney Road; thence with the center of said road S. 50 W. 11.7 feet to the beginning corner.

Being the same premises conveyed to D. R. Evins by deed recorded in Deed Book 276, Page 242, and conveyed to the mortgagor by deed of D. R. Evins recorded in Deed Book 634, Page 524.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
