TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Grover P. Mason and Betty J. Mason,

(hereinafter referred to as Mortgagor) SEND(S) GREETING.

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Thirty-five Hundred -----
DOLLARS (\$ 3500.00), with interest thereon from date at the rate of Six & one-half (6½%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, lying on the south side of the Washington-Oneal Road, near Washington Baptist Church, containing two acres, more or less, and having the following courses and distances, to-wit:

BEGINNING at a point on said (iron pin on south bank), and runs thence S. 64-15 W. 196 feet to an iron pin; thence S. 3-45 E. 266 feet to an iron pin; thence S. 83-25 E. 231.5 feet to stone on Dill line; thence N. 6-38 E. 376 feet to iron pin, corner of Bull land; thence N. 89-15 W. 113½ feet to beginning corner.
