"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Highland Township, and having the following metes and bounds:

BEGINNING at an iron pin in the center of a road leading to Highland on the Reece Griffin corner, and running S, 82 W 245.5 feet to iron pin; thence N 48-20 W. 270 feet to iron pin at head of gully; thence N 37-19 E 116.5 feet to pin in said gully; thence N. 54-30 E. 159 feet to point in center of above mentioned road; thence with center of said road, S. 36-42 E. 413.4 feet to the beginning corner.
