(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighty-three Hundred and No/100 ----- DOLLARS (\$ 8300.00 ), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the North Franklin Road, and having, according to a survey thereof made by R. E. Dalton, Eng., February 12, 1930, recorded in the R. M. C. Office for Greenville County in Plat Book G at Page 259, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of North Franklin Road, joint corner of property now or formerly of W. J. Thackston, and the property herein conveyed, and running thence along the western side of said North Franklin Road, N. 21-12 W. 32.5 feet to an iron pin; thence continuing with said road N. 22-47 W. 159 feet to an iron pin; thence continuing with said road N. 33-25 W. 100 feet to an iron pin; thence continuing with said road N. 41-16 W. 22.5 feet to an iron pin; thence S. 54-49 W. 444.8 feet to an iron pin at corner of lot heretofore conveyed by Rachel Geer Keys (nee Rachel Rice Geer) to Margaret S. McKissick; thence with said McKissick line, S. 39-30 E. 110.5 feet to a large poplar tree; thence N. 81-28 E. 438 feet to an iron pin on the west side of North Franklin Road, the beginning corner.

Being the same premises conveyed to the mortgagor by deed recorded in Deed Book 308, Page 289.
