G. D. EBERHARDT (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ten Thousand and No/100 -----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the southern side of West Belvedere Road, near the City of Greenville, being shown as Lot 181, on plat of South Forest Estates recorded in Plat Book GG, Page 181, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of West Belvedere Road at the joint front corner of Lots 180 and 181 and running thence with the line of Lot 180 S. 8-29 W. 142.3 feet to an iron pin; thence S. 78-04 E. 27.4 feet to an iron pin; thence continuing S. 82-45 E. 56.7 feet to pin at rear corner of Lot 182; thence with the line of Lot 182 N. 8-29 E. 142.8 feet to an iron pin on West Belvedere Road; thence with the southern side of West Belvedere Road N. 81-31 W. 84 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
