This is a second mortgage over the above described property, being second and junior to a first mortgage over same, executed by us to John A. Park, dated July 20, 1949, recorded in Vol. 432 at page 357 in said R.M.C. office on July 21, 1949; but there are no other mortgages, judgments, nor other liens or encumbrances over or against same prior to this mortgage.
