NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and furthersums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville and having the following courses and distances, to-wit:

Beginning at an iron pin on the Southeast side of County road leading west from the old Greenville-Laurens Highway to Leake's Dairy at corner of property now or formerly of H. I. Gault and running thence along said Gault property S. 2-05 E. for a distance of 603 feet to a stone; thence S. 79-0 W. for a distance of 572 feet to an iron pin on the Southeast edge of said County road; thence along the Southeast side of said County road, N. 36-30 E. for a distance of 900 feet to the beginning corner and containing three and ninety-seven one hundredths (3.97) acres, more or less.
