ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being on the northern side of Campbell Street in the City of Green-ville, being known as the eastern portion of Lot No. 2 and a small triangular portion of the western side of Lot No. 1, as shown on a plat of University Circle made by Piedmont Engineering Service, May, 1948, said plat being recorded in the R.M.C. Office of Greenville County, South Carolina, in Plat Book "Y", at Page 111; and being more specifically shown on a plat made by R. K. Campbell, Engineer, April 29, 1960, recorded in the R.M.C. Office of Greenville County, South Carolina, in Plat Book "TT", at Page 24, and having, according to said plat, the following metes and bounds, to-wit:
