All that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being on the Southeasterly side of Inglewood Drive (formerly Olwell Avenue), in the City of Greenville, South Carolina, being shown as the greater portion of Lot No. 14 on a plat of a revision of a portion of Craftstone Acres, made by Piedmont Engineering Service, dated 8 August, 1950, and recorded in the RMC Office for Greenville County, S. C., in Plat Book Y, Page 91 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeasterly side of Inglewood Drive at the joint front corner of Lots 14 and 15, said pin being located 170 feet northeast of the Northeasterly corner of the intersection of Inglewood Drive and Summit Drive, and running thence along the joint line of said lots S 46-20 E 137.3 feet to an iron pin; thence along the line through Lot No. 14 N 45-28 E 69.9 feet to an iron pin joint corner of Lots 12, 13 and 14; thence along the joint line of Lots 13 and 14 N 46-20 W 120 feet to an iron pin on the Southeasterly side of Inglewood Drive; thence along the Southeasterly side of said Drive S 45-40 W 70 feet to the point of beginning.
