To All Whom These Presents May Concern:

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 20 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

BEGINNING at an iron pin at the joint corner of Lots Nos. 102 and 101, on the western side of Longwood Drive, and running thence along the line of Lot No. 101, S. 59-35 W. 163 feet to an iron pin in the line of Lot No. 97; running thence N. 30-18 W. 90 feet to an iron pin on the southwest side of Merrywood Drive; thence along the southwest side of Merrywood Drive, N. 61-10 E. 40.6 feet to an iron pin; thence continuing along the southwest side of Merrywood Drive, N. 59-05 E. 97.6 feet, to an iron pin at an intersection, which intersection is curved, the chord of which is S. 75-55 E. 35.4 feet to an iron pin on the southwest side of Longwood Drive; thence along the southwest side of Longwood Drive, S. 30-55 E. 45.5 feet to an iron pin; thence continuing along the southwest side of Longwood Drive, S. 28-52 E. 19.5 feet to an iron pin, point of beginning; being the same property conveyed to me by Williams Land Company, Inc. by deed dated June 30th, 1960 to be recorded herewith.
