To All Whom These Presents May Concern:

I, Henry C. Harding, of Greenville County,

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Seven Thousand, Four Hundred and no/100. (\$7,400.00.) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain Township, being the greater portion of Lot No. 143 of a subdivision known as Western Hills as shown on plat thereof prepared by Jones & Sutherland, August, 1959, and recorded in the R. M. C. office for Greenville County in Plat Book QQ, pages 98 and 99, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on Provo Drive, the joint front corner of Lots 142 and 143, and running thence along the north side of Provo Drive, following the curvature thereof, the chord of which is N. 72-58 W. 75 feet to an iron pin; thence continuing along Provo Drive, N. 83-45 W. 25 feet to an iron pin; thence continuing along Provo Drive, N. 85-25 W. 25.2 feet to an iron pin; thence following the curvature of Provo Drive as it intersects with Alice Farr Drive, the chord of which is N. 44-23 W. 36.7 feet to an iron pin on the eastern side of Alice Farr Drive, thence along the eastern side of Alice Farr Drive, N. 0-09 W. 64.1 feet to an iron pin; thence continuing along the eastern side of Alice Farr Drive, following the curvature thereof, the chord of which is N. 15-01 E. 72.5 feet to a new corner; thence along a new line through Lot No. 143, S. 55-44 E. 219.7 feet to an iron pin at the joint rear corner of Lots 143 and 144; thence along the line of Lot 142, S. 38-44 W. 83.3 feet to the beginning corner; being a portion of the property conveyed to me by J. Frank Williams by his deed dated May 7, 1960, recorded in the R. M. C. office for Greenville County in Vol. 650, at page 224."
