Ross and wife, Clovis Ross' old line S 79-45 E 300' to a new corner; thence a new line on Pellan L. And it is Further Agreed, by and between the said parties, that the said Mart Leon Cole and wife, Shirley Elaine Cole their Heirs, Executors or Administrators, shall and will insure the house and buildings on said lot, and keep the same insured from loss or damage by fire, and assign the Policy of Insurance to the said Modern Homes Construction Com-
