ALL that piece, parcel or lot of land, situate, lying and being on the Western side of Stratford Road, near the City of Greenville, County of Greenville, State of South Carolina and known and designated as Lot No. 117 of a Subdivision known as South Forest Estates, plat of which is recorded in the R.M.C.
